



How to use the Kitemark



The Kitemark is a certification mark owned by BSI and registered under the Trade Marks Act 1994. it may only be used under Licence from BSI, or under Sub-licence from a Licensee, and in accordance with the requirements of the Kitemark Licence of Contract, as may from time to time be updated by BSI (the 'Conditions'), which include this document. All defined terms in this document shall have the same meaning as in the Conditions.

The appearance of the Kitemark upon a Product is confirmation by BSI that the Licensee's claim of conformity with a stated Standard is correct.

BSI encourages the maximum use of the Kitemark to enable Licensees and their customers to derive the upmost benefit from it, and is always pleased to provide advice and guidance on its correct use.

The manner in which the Kitemark is drawn as illustrated. No modification, stylising or addition to this design is permitted without the prior written agreement of BSI.

The Kitemark in colour

The Kitemark, including the Product Standard number (and the Kitemark Licence number, if appropriate), may appear in any colour, provided the colour is consistent throughout.

The Kitemark size

The minimum size of display of the Kitemark is not prescribed. However, it should not be displayed in a size such that it is unclear or the Standard number is unreadable.

On Certified Products and/or their Packaging

The Kitemark must always appear on the certified Product and/or its packaging with the relevant Product Standard number in close proximity (see left).

On Products where marking is difficult

Where marking is difficult or impractical due to the size, aesthetics or nature of the product, e.g. bulk fluids, alternative marking arrangements may be used by prior written agreement with BSI.

On Products sold or supplied under a name other than that of the Licensee

The use of the Kitemark on a Product sold or supplied under a name other than that of the Licensee who provides or produces it is permitted by BSI.

In such a case the Kitemark and the number of the Product Standard must be accompanied, in close proximity, by the Kitemark Licence number in order to identify the Licensee (see bottom left).

On promotional literature, letterheads, in publicity and at exhibitions

The Kitemark may be used by the Licensee and any Sub-licensee on promotional literature, on letterheads, in publicity and on exhibition stands but only in relation to the Products listed on the current Kitemark Licence schedule. It signifies certification in relation to the criteria specified in the Product Standard. Care should be taken to avoid its use in a manner which implies or could imply that other products are certified, e.g. implying that a whole product is certified of which the certified Product forms only a part. The method of display of the Kitemark depends on whether the Product is sold or supplied under the Licensee's, or someone else's name.
